# Federal Assistance for Maui Survivors Tops \$125 Million

Since wildfires swept over the Island of Maui Aug. 8, more than **\$125.16 million** in federal assistance has been approved for **5,756** households. FEMA is working closely with Maui County, the State of Hawaii and federal and nonprofit partners, with a commitment to helping Maui residents continue their recovery.

#### **Recovery by the Numbers**

- FEMA has approved \$26,172,161 for individuals and households, including:
  - **\$12,512,400** approved for housing assistance; and
  - **\$13,659,761** approved for Other Needs Assistance.
- The U.S. Small Business Administration has approved \$98,993,300 in disaster loans for affected Maui homeowners, renters and businesses.
- Three Maui County Disaster Recovery Centers are open in Kahului, Lāhainā and Makawao. At the centers, survivors can speak to FEMA specialists, get help applying for disaster assistance, connect with voluntary organizations and access other federal and state resources. The centers are open from 8 a.m. to 7 p.m. seven days a week. The Lāhainā Disaster Recovery Center will close at 3 p.m. today. Some 10,096 survivors have visited the Disaster Recovery Centers since the first center opened Aug. 16.
- **812** federal responders are on the ground today assisting survivors.

## The American Red Cross Continues to Assist Wildfire Survivors

The American Red Cross is providing funeral assistance, mental health assistance and other services to survivors, including survivors who are not eligible for some FEMA programs. Disaster survivors are encouraged to schedule an appointment with the Red Cross at <u>RedCross.org/Hlhelp</u> or speak to a Red Cross representative at any Disaster Recovery Center.

# **Continued Rental Assistance for Maui Wildfire Survivors**

Residents of Maui who were affected by the Aug. 8 wildfires and received an initial rental assistance from FEMA may be eligible for continued rental assistance. #### How to Appeal FEMA's Decision

An appeal is a written request to FEMA to review your application for disaster assistance. It is also an opportunity to provide new or additional information not previously submitted that may affect FEMA's decision. #### Visit MauiRecovers.org for Reopening and Recovery Information

- Wildfire survivors can visit the Maui County website Maui Recovers (<u>mauirecovers.org</u>) for comprehensive information about re-entry to damaged areas, safety alerts and debris removal. You can also sign up for text or email updates and get answers to frequently asked questions.
  - Two more zones within burned area have reopened to the public: **5B**, the Lāhainā Cannery Mall, and zone **5E**, covering some of the businesses on Kupuohi and Ulupono streets.

  - Representatives of Maui County and the Retired Senior Volunteer Program, or RSVP, will be at the Lāhainā Civic Center Gymnasium to help residents complete and submit their re-entry forms. This service is offered from 8 a.m. to 4 p.m. daily, except today, when help will be provided from 8 a.m. to 3 p.m.

## Apply Now for D-SNAP Benefits; One Day Left

- Maui wildfire survivors can apply for Disaster Supplemental Nutrition Assistance, or D-SNAP, benefits through Sept. 23. D-SNAP benefits can be used to buy food at grocery stores and other authorized retailers that accept electronic benefit transfer, or EBT. <u>The application period closes tomorrow.</u>
  - D-SNAP benefits are available to people whose primary residences or place of employment are in Lāhainā or Kula (ZIP codes 96790, 96791 and 96767).

## **U.S. Small Business Administration**

- The U.S. Small Business Administration offers several kinds of low-interest loans to disaster survivors.
- The Small Business Administration is offering low-interest disaster loans to survivors, including up to \$500,000 for homeowners to repair or replace their homes and up to \$100,000 in personal property loans for homeowners and renters to replace damaged or destroyed personal property. - The deadline to apply for FEMA assistance and a low-interest disaster loan from the U.S. Small Business Administration is <u>Tuesday, Oct. 10</u>. The last day for small businesses, small agricultural cooperatives and most private nonprofit organizations to apply for an SBA economic injury loan is <u>Friday, May 10, 2024</u>.
